

Privacy Policy

We respect your privacy and are committed to protecting your personal data.

This privacy policy applies between you, the User of this Website and Padel Up Limited (trading as Sevenoaks Padel and / or 7oakspadel), the owner and provider of this Website.

Padel Up Limited takes the privacy of your information very seriously. This privacy policy applies to our use of any and all Data collected by us or provided by you in relation to your use of the website, digital communications, the booking app or at the premises.

Please read this privacy policy carefully.

Definitions and interpretation

1. In this privacy policy, the following definitions are used:

“Data” - collectively all information that you submit to Padel Up Limited (and any subsidiaries) via the Website, digital communications, booking app or at the premises. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;

“Cookies” - a small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below (**Cookies**);

“Data Protection Laws” - any applicable law relating to the processing of personal Data, including but not limited to the General Data Protection Regulation (EU) 2016/679 (GDPR), and any national implementing laws, regulations and secondary legislation, for as long as the GDPR is effective in the UK;

“Padel Up Limited” - (We or Us), a company incorporated in England and Wales with registered number **15375617** whose registered office is at 71-75 Shelton Street, Covent Garden, London, United Kingdom, WC2H 9JQ.

“UK and EU Cookie Law” - the Privacy and Electronic Communications (EC Directive) Regulations 2003 as amended by the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2011;

User or you - any third party that accesses the Website and is not either (i) employed by Padel Up Limited and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to Padel Up Limited and accessing the Website in connection with the provision of such services; and

Website

The website that you are currently using, www.sevenoakspadel.co.uk or www.7oakspadel.co.uk, and any sub-domains of this site unless expressly excluded by their own terms and conditions.

2. In this privacy policy, unless the context requires a different interpretation:
 - a. the singular includes the plural and vice versa;
 - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d. "including" is understood to mean "including without limitation";
 - e. reference to any statutory provision includes any modification or amendment of it;
 - f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

3. This privacy policy applies only to the actions of Padel Up Limited and Users with respect to this Website and our owned social media. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites and communications platforms including WhatsApp.

4. For purposes of the applicable Data Protection Laws, Padel Up Limited is the "data controller". This means that Padel Up Limited determines the purposes for which, and the manner in which, your Data is processed.

Data collected

5. We may collect the following Data, which includes personal Data, from you:

- a. name;
- b. date of birth;
- c. gender;
- d. job title;
- e. profession;
- f. contact Information such as email addresses and telephone numbers;
- g. demographic information such as postcode, preferences and interests;
- h. IP address (automatically collected);
- i. web browser type and version (automatically collected);
- j. operating system (automatically collected);
- k. a list of URLs starting with a referring site, your activity on this Website, and the site you exit to (automatically collected);

in each case, in accordance with this privacy policy.

How we collect Data

6. We collect Data in the following ways:

- a. data is given to us by you ;
- b. data is received from other sources; and
- c. data is collected automatically.

Data that is given to us by you

7. Padel Up Limited will collect your Data in a number of ways, for example:

- a. when you contact us through the Website, by telephone, post, e-mail or through any other means;
- b. when you register with us and set up an account to receive our products/services;
- c. when you enter a competition or promotion through a social media channel;
- d. when you elect to receive marketing communications from us;
- e. when you use our services; communication via social media accounts and Whatsapp.

in each case, in accordance with this privacy policy.

Data that is received from third parties

8. Padel Up Limited will receive Data about you from the following third parties:

Data that is collected automatically

10. To the extent that you access the Website, we will collect your Data automatically, for example:

- a. we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.

b. we will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed "Cookies".

Our use of Data

11. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:

- a. internal record keeping;
- b. improvement of our products / services;
- c. transmission by email of marketing materials that may be of interest to you;

in each case, in accordance with this privacy policy.

12. We may use your Data for the above purposes if we deem it necessary to do so for our legitimate interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed "Your rights" below).

13. For the delivery of direct marketing of Padel Up Limited and selected brand partners to you via e-mail, we'll need your consent, whether via an opt-in or soft-opt-in:

a. soft opt-in consent is a specific type of consent which applies when you have previously engaged with us (for example, you contact us to ask us for more details about a particular product/service, and we are marketing similar products/services). Under "soft opt-in" consent, we will take your consent as given unless you opt-out.

b. for other types of e-marketing, we are required to obtain your explicit consent; that is, you need to take positive and affirmative action when consenting by, for example, checking a tick box that we'll provide.

c. if you are not satisfied about our approach to marketing, you have the right to withdraw consent at any time. To find out how to withdraw your consent, see the section headed "Your rights" below.

14. When you register with us and set up an account to receive our services, the legal basis for this processing is the performance of a contract between you and us and/or taking steps, at your request, to enter into such a contract.

15. We may use your Data to show you Padel Up Limited adverts and other content on other websites. If you do not want us to use your data to show you Padel Up Limited adverts and other content on other websites, please turn off the relevant cookies (please refer to the section headed "Cookies" below).

Who we share Data with

16. We may share your Data with the following groups of people for the following reasons:

- a. any of our group companies or affiliates - to ensure the proper and correct use of our website and interaction with your business;
- b. our employees, agents and/or professional advisors - to obtain advice and provide a bespoke service to your business;
- c. third party service providers who provide services to us which require the processing of personal data - to help third party service providers in receipt of any shared data to perform functions on our behalf to help ensure the website operates effectively and provides a personalised experience; in each case, in accordance with this privacy policy.

WhatsApp

17. Padel Up Limited operate a WhatsApp Community and subsequent groups for players to communicate socially. You can join, or get added to groups and broadcast lists, for Padel Up Limited, and as such groups and lists will get associated with your account information.

By joining these groups or lists, you are giving Padel Up Limited and other members of the Groups or Lists, access to your personal phone number, profile picture and status. Being part of these groups or lists, means that you have accepted the Terms of Use and Privacy Policy.

You are able to remove yourself, or request to be removed, from Padel Up Limited's groups or lists at any time. Padel Up Limited has the right to remove any player who is not adhering to the Community's Groups or lists acceptable behaviour.

Padel Up Limited accepts no responsibility and/or liability for any scam or phishing attempts by external parties, and strongly advise to delete any such messages. We do not encourage the wider sharing of this Group or List invitation, and request that if you wish to add a player, that you contact Padel Up Limited at info "at" SevenoaksPadel.co.uk.

Keeping Data secure

18. We will use technical and organisational measures to safeguard your Data, for example:

- a. access to your account is controlled by a password and a user name that is unique to you.
- b. we store your Data on secure servers.

19. Technical and organisational measures include measures to deal with any suspected data breach. Data retention

21. Unless a longer retention period is required or permitted by law, we will only hold your Data on our systems for the period necessary to fulfil the purposes outlined in this privacy policy or until you request that the Data be deleted.

22. Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

Your rights

23. You have the following rights in relation to your Data:

a. **Right to access** - the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.

b. **Right to correct** - the right to have your Data rectified if it is inaccurate or incomplete.

c. **Right to erase** - the right to request that we delete or remove your Data from our systems.

d. **Right to restrict our use of your Data** - the right to "block" us from using your Data or limit the way in which we can use it.

e. **Right to data portability** - the right to request that we move, copy or transfer your Data.

f. **Right to object** - the right to object to our use of your Data including where we use it for our legitimate interests.

26. It is important that the Data we hold about you is accurate and current. Please keep us informed if your Data changes during the period for which we hold it.

This privacy policy does not extend to your use of such websites. You are advised to read the privacy policy or statement of other websites prior to using them.

28. Padel Up Limited reserve the right to use videography and/or photography on the premises, included but not limited to, the courts and spectator areas. By booking a court at Padel Up Limited, you are accepting the terms of use and privacy policy. Booking app

29. Padel Up Limited operates a booking app. The app may change, be updated or replaced without notice. There are booking restrictions, which are set in the booking app.

Changes of business ownership and control

30. Padel Up Limited may, from time to time, expand or reduce our business and this may involve the sale and/or the transfer of control of all or part of Padel Up Limited. Data provided by Users will, where it is relevant to

any part of our business so transferred, be transferred along with that part and the new owner or newly controlling party will, under the terms of this privacy policy, be permitted to use the Data for the purposes for which it was originally supplied to us.

31. We may also disclose Data to a prospective purchaser of our business or any part of it.

32. In the above instances, we will take steps with the aim of ensuring your privacy is protected.

Cookies

33. This Website may place and access certain Cookies on your computer. Padel Up Limited uses Cookies to improve your experience of using the Website and to improve our range of services. Padel Up Limited has carefully chosen these Cookies and has taken steps to ensure that your privacy is protected and respected at all times.

34. All Cookies used by this Website are used in accordance with current UK and EU Cookie Law.

35. Before the Website places Cookies on your computer, you will be presented with a message bar requesting your consent to set those Cookies. By giving your consent to the placing of Cookies, you are enabling Padel Up Limited to provide a better experience and service to you. You may, if you wish, deny consent to the placing of Cookies; however certain features of the Website may not function fully or as intended.

36. This Website may place the following Cookies:

Type of Cookie and purpose

Strictly necessary cookies

These are cookies that are required for the operation of our website. They include, for example, cookies that enable you to log into secure areas of our website, use a shopping cart or make use of e-billing services.

Analytical/performance cookies

They allow us to recognise and count the number of visitors and to see how visitors move around our website when they are using it. This helps us to improve the way our website works, for example, by ensuring that users are finding what they are looking for easily.

Functionality cookies

These are used to recognise you when you return to our website. This enables us to personalise our content for you, greet you by name and remember your preferences (for example, your choice of language or region).

Targeting cookies

These cookies record your visit to our website, the pages you have visited and the links you have followed. We will use this information to make our website and the advertising displayed on it more relevant to your interests. We may also share this information with third parties for this purpose.

General

42. You may not transfer any of your rights under this privacy policy to any other person. We may transfer our rights under this privacy policy where we reasonably believe your rights will not be affected.

43. If any court or competent authority finds that any provision of this privacy policy (or part of any provision) is invalid, illegal or unenforceable, that provision or part-provision will, to the extent required, be deemed to be deleted, and the validity and enforceability of the other provisions of this privacy policy will not be affected.

44. Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.

45. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.

Changes to this privacy policy

46. Padel Up Limited reserves the right to change this privacy policy as we may deem necessary from time to time or as may be required by law. Any changes will be immediately posted on the Website and you are deemed to have accepted the terms of the privacy policy on your first use of the Website following the alterations.
